






MAP 3 LANDS ENROLLED IN FARMLAND PRESERVATION

Town of West Point Columbia County, Wisconsin












MAP 5 PRODUCTIVE AGRICULTURAL SOILS








MAP 6 WOODLANDS & MANAGED FOREST LAW














MAP 8 WETLANDS & HYDRIC SOILS Town of West Point Columbia County, Wisconsin
