A motion was made by Matt Zeman to vote by a show of hands, 2^{nd} by Bill Neimi – yes 18 - no 1 - motion carried.

The financial report for 2012 was presented to the people for their consideration. The financial report was also handed out on Election Day. Chairman Dean Schwarz went over each account of the financial report which was prepared by Johnson Block and Company, Inc. The balances on hand as of December 31, 2012 were as follows:

Fred Thistle asked if Scott Ness knew what the cost would be. Dean Schwarz suggested speaking with Spellman Monument Company. Scott Ness is going to get quotes from companies for restoring monuments.

Dean Schwarz stated the town will be putting up some "No outlet" and "Dead End" signs on the street signs.

Kevin Kessler stated Columbia County is working on taking over the care of ordering and replacing Emergency Response Number signs.
