## TOWN OF WEST POINT

Pursuant to WI State Statues 60.12 the annual town meeting of the Town of West Point was held on Tuesday, April 21, 2015 at the West Point Town Hall. The meeting was published, posted in three places and on the web site. There were 7 electors present at the start of the meeting, 2 more electors arrived later.

Dean Schwarz, Town Chairman called the annual town meeting to order at 7:03 p.m.

A motion was made by Matt Zeman to vote by a show of hands,  $2^{nd}$  by Ashley Nedeau-Owen – yes 7 – no 0– motion carried.

The financial report for 2014 was presented to the people for their consideration. The financial report was also handed out on Election Day. Chairman Dean Schwarz went over each account of the financial report which was prepared by Taffy Buchanan, Town Clerk. The balances on hand as of December 31, 2014 were as follows:

Questions from town residents were answered. A motion was made by Edie Eberle to accept the 2014 Financial Statement as presented,  $2^{nd}$  by Lonna Zeman - yes 9 - no 0 - motion carried.

The minutes were read for the April 15, 2014 annual town meeting by the town clerk Taffy Buchanan. A motion was made by Matt Zeman to

approve the minutes, 2<sup>nd</sup> by Ashley Nedeau-Owen – yes 9 – no 0 – motion carried.

Making a donation to Garden Bluff Cemetery and the American Legion Post 216 was brought up to the town residents for consideration. A motion was made by John Miller to donate \$800.00 to Garden Bluff Cemetery and \$125.00 to the American Legion Post 216 for Memorial Day Funds, 2<sup>nd</sup> by Lonna Zeman, – yes 9– no 0 – motion carried.

A motion was made by Gordon Carncross to direct the Town Board to put the following Resolution on the 2016 Spring Election as a Referendum: Be it resolved the people of West Point, in Columbia Co., WI, stand with the Move to Amend campaign and communities across the country to defend democracy from the corrupting effects of undue corporate power by amending the United States Constitution to establish that: 1...) Only human beings, not corporations, are endowed with constitutional rights, and 2.) Money is not speech, and therefore regulating political contributions and spending is not equivalent to limiting political speech. Be it further resolved, that the people of West Point in Columbia County, WI., hereby instruct our state and federal representatives to enact resolutions and legislation to advance this effort, 2<sup>nd</sup> by Ashley Nedeau-Owen, yes 8 – no 0 – abstain 1 – motion carried.

A motion was made by Ashley Nedeau-Owen to recommend to the Town Board to borrow \$200,000.00 for road construction,  $2^{nd}$  by Edie Eberle – yes 9 - no 0 - motion carried.
