<u>Agenda #2 – Approval of Agenda –</u> A motion was made by Fred Madison to approve the agenda as presented, 2nd by Renee Nair – motion carried unanimously.

<u>Agenda #3 Approve Minutes</u> – Copies of the February 5, 2015 Plan Commission minutes had been emailed to each member for their review. A motion was made by Fred Madison to approve the minutes with corrections, 2nd by Renee Nair - motion carried unanimously.

Agenda # 6 Public Hearing for A Conditional Use Permit and Rezoning request has been received from James Meister & Craig Meister, W11924 County Highway V, Lodi, WI. 53555 - Tax Parcel # 541.02 & 541.C in Sec. 7, T10N, LT 2, Town of West Point. The Conditional Use Permit and Rezoning request is to rezone a portion of the parcels from A-1 Agriculture to A-3 Agriculture Business with a Conditional Use Permit to operate a contractor's yard on this lot. – The public hearing was opened at 7:12pm. Taffy Buchanan, Town Clerk, stated 20 letters were sent to landowners within 1000 feet. Craig Meister was in attendance as the applicant for the rezoning and CUP. No one else presented comments or registered at the public hearing and no written comments were received. The public hearing was closed at 7:18pm.

A motion was made by Kevin Kessler to table the previous motion, 2nd by Nathan Sawyer – motion carried unanimously. A motion was made by Kevin Kessler to recommend to the Town Board that each of the 7 Finding of Facts are satisfied on the County form in accordance with the County Ordinance, 2nd by Fred Madison – motion carried unanimously. A motion was made by Kevin Kessler to amend the tabled motion to include "subject to the conditions suggested by the Planning & Zoning Department; that processing be limited to the crushing of concrete, screening of black dirt, and fire wood processing; and there be a condition regarding the volume of material stored on site for recycling", 2nd by Fred Madison – motion carried unanimously. Chairman Kevin Kessler took the amended motion off the table -Fred Madison motioned to recommend to the Town Board to approve the CUP and rezoning subject to the conditions suggested by the Planning & Zoning Department; that processing be limited to the crushing of concrete, screening of black dirt, and fire wood processing; and there be a condition regarding the volume of material stored on site for recycling, 2nd by Gordon Carncross – motion carried unanimously.
