### 2022 Real Estate & Personal Property Taxes

1<sup>st</sup> installment tax payments need to be postmarked by January 31, 2023 to be considered timely.

Tax payments can be made in person at the Town Hall, by mail or online.

1. The Treasurer will accept tax payments at the Town Hall on the following dates:

- Friday Dec 30<sup>st</sup>: 11am – 6pm
- Friday Jan 6<sup>th</sup>: 10am – 2pm
- Friday Jan 13<sup>th</sup>: 10am – 6pm
- Wednesday Jan 25<sup>th</sup>: 12pm – 6pm
- Monday Jan 30<sup>th</sup>: 10am – 2pm

When searching for your property tax record(s) first select our Municipality: 11040 – Town of West Point.

You can search by parcel number, last name, street name, etc. “Less is more” when it comes to searching. For instance, search for just your last name OR your street name, but NOT both.

Click on the red parcel link and then select the Taxes option in the Select Detail dropdown.

### TRANSFER SITE

**NOTICE:** It is time to pick up a new Transfer Site Permit. Permits can be picked up starting in December at the Town Hall during normal business hours.

As of January 1, 2022, rules changed as to what the Town would be able to accept at the Transfer Site. Please check the Town’s website at [www.townofwestpoint.us](http://www.townofwestpoint.us) for specific information. Copies are also available at the Town Hall.

Construction dumpsters are available during the months of May and September only. Dumpster use is on a first come first serve basis. The Ag & Silage Plastic dumpster is available at the Transfer Site year-round.

### 2022 Dog Licenses



Wisconsin State Statues 174.05 and 174.07(1)(b) requires ALL DOGS over the age of 5 months to be licensed **annually** by the Municipal Treasurer. Licensing your dog requires proof of rabies vaccination.

### Licensing fees:

- \$5 for spayed or neutered dogs
- \$10 for unspayed or unneutered dogs.

Please include a self-addressed stamped envelope along with your payment when purchasing via mail. *Note: extra postage is required when licensing multiple dogs.*
